Mayor Watkins read the next item on the agenda. It was **moved by** Daniel Hennigan, **seconded by** Vernessa Guillory to order an inspection report for the building located at 102 S Stockwell for the purpose of condemnation. The motion passed unanimously.

Mayor Watkins read the next item on the agenda. It was **moved by** Daniel Hennigan, **seconded by** Vernessa Guillory to order inspection report for building located at 415 S Storer for the purpose of condemnation. The motion passed unanimously.

Mayor Watkins read the next item on the agenda. Mayor explained that we have done our due diligence in this process and the 45 days granted to the owners have passed and nothing has been done. Cindy Mallett explained the process of Notice of Demolition. It was **moved by** Daniel Hennigan, **seconded by** Joe Becnel to order Notice of Demolition within 30 days for 110 S Bowers Avenue. The motion passed unanimously.

Mayor Watkins read the next item on the agenda. It was moved by Joe Becnel, seconded by Vernessa Guillory to order Notice of Demolition within 30 days for 500 Railroad Avenue. The motion passed unanimously.

Mayor Watkins read the next item on the agenda. Mayor Watkins reported that the Fire District does have all their paperwork straight and the truck arrived in Eunice today. It was **moved by** Daniel Hennigan, **seconded by** Vernessa Guillory to approve Cooperative Endeavor Agreement between the Town of Iowa and Fire Protection District No. One of Ward Eight and authorize Mayor Watkins to execute agreement. The motion passed unanimously.

Mayor Watkins read the next item on the agenda.

a. Upon the recommendation of Chief Vincent, it was moved by Daniel Hennigan, seconded by Vernessa Guillory to promote Jeanine Dugas from Patrolman to Patrolman First Class. The motion passed unanimously.

- b. Upon the recommendation of Chief Vincent, it was moved by Daniel Hennigan, seconded by Vernessa Guillory to transfer Denasja Dartest from part-time to full-time dispatcher effective October 20, 2023. The motion passed unanimously.
- c. Mayor Watkins asked Chief Vincent questions concerning the agreement assigning Russell Jimenez to the U.S. Marshall's Task Force. He asked if we would have to maintain records such as body camera records when he would be working with the U.S. Marshal Task Force. Chief said he would look into this but that he would not have to use the town's body cameras so we shouldn't have to maintain any records. He also asked if the town would be paying overtime for any hours worked with the Marshal's Office. Chief Vincent said the town would not be paying overtime for this task force. Upon the recommendation of Chief Vincent, it was moved by Daniel Hennigan, seconded by Vernessa Guillory to assign Russell Jimenez to the U.S. Marshal's Task Force. The motion passed unanimously.

Mayor announced that we didn't have a finance report because of the glitches in the computer system. Clerk Cindy Mallett said that a report will be provided at next meeting.

Mayor mentioned, in connection with the report from Bluewing Civil, that it was a provision that was a result of a conversation with Gravity Drainage. He stated that there are issues along the lateral. He said there are a couple of places that need to be taken care of. Once they tell us what can be done then it will be taken care of.

Mayor asked if there was anyone else that had anything to say. Ms. Leonard talked about her research on the necessity of sleep and the noise ordinance. Mayor discussed the ordinance, and the lack of respect people have. There was discussion about the noise ordinance and how it could be enforced.

Pam Adams, Fire District Board Member, thanked the Mayor and Clerk for helping the Fire District in getting the paperwork done to get the new fire truck.

With no further business it was moved by Daniel Hennigan, seconded by Joe Becnel to adjourn the meeting. The meeting was adjourned at 7:25 pm.
